COURSE DESCRIPTION

This course continues the EECE401 Senior Design I focused on completing the engineering design principles, "applying technical knowledge to meet people's needs," and the process of design to meet the needs. Students continue to participate in team activities and learn how to become an effective team member and an effective communicator by practice. Most of all, the main goal of this course is to convert the solution design in to reality: project solution implementation. Therefore, additional emphasis is placed on project management with risk assessment and agile development. Progress will be checked through progress presentations. The culmination of these courses is the final project presentation and demonstration with public audience invited.
